

## TERMS OF SERVICE for Casagram ICO

- Casacoin (hereinafter referred to as 'Casagram coins', or 'Casagram tokens', or 'Casagram digital tokens', or 'casagram.net', or 'Casa') Initial Coin Offering (ICO) of Casagram tokens on our website i.e. [www.casagram.net](http://www.casagram.net).
- The following terminology applies to these Terms and Conditions of Use (our "Terms"), the Privacy and Transparency Statement, and any and all other agreements between you and us:
  - "Client," or "Customer," or "User," or "You," or "Your" refer to the person accessing our website i.e. [www.casagram.net](http://www.casagram.net), and accepting our Terms.
  - "We", or "Our", or "Ourselves", or "Us" or "Casagram" or "[www.casagram.net](http://www.casagram.net)," refer to the internet website [casagram.net](http://casagram.net), and to its owners, operators, employees, agents, insurers, suppliers, and attorneys.
  - "Party" refers to either you or us. In these Terms, unless the context otherwise provide, words indicating the singular shall be understood to include the plural and vice versa and words indicating gender include all genders.
